Thank you for your request dated 1 July 2015 under the Freedom of Information (Scotland) Act 2002 (FOISA) for:

- How many sexual offences were reported as having taken place in the prison system, for each year in 2014, 2013, 2012, 2011, 2010?
 - Of these, how many of the alleged victims were under the age of 18 at the time of the incident?
 - Of these, how many were incidences of rape, and how many were incidences of sexual assault?
 - Of these, how many of allegations were made against prison staff, and how many were made against other prisoners?
 - Of these, how many of the alleged victims were male, and how many were female?
 - Of these, how many of the alleged victims were prisoners and how many were prison staff.
