Executive Summary

Custodial history

One fifth (20%) of prisoners said that they were on remand at the time of completing the 2017 prisoner survey; 80% had been sentenced. Over a quarter of prisoners said that they had 'never' previously been on remand (29%). Sixteen percent of those reporting had been on remand 'over 10 times' and one tenth between '6 and 10 times' (11%).

One third of those reporting had 'never' previously served a prison sentence (35%), while four in ten had served between '1 and 5 sentences' (39%), 11% between '6 and 10 sentences' and 15% had served 'over 10 sentences'.

Overall drug use

There is a considerable difference between those prisoners who had 'never' served a custodial sentence before and those who had served 'over 10 times' in relation to illegal drug use in prison (14% & 77% respectively) and illegal drug use in the last month (6% & 50% respectively). Just under half (48%) of the 'over 10 times' group were being prescribed methadone compared to six percent of the 'never' group.

Overall drug use at time of offence

Over half of prisoners who reported that their drug taking was a problem for them on the outside had been in prison on a sentence '6-10 times' (57%) or 'over 10 times' (57%), compared with a fifth who had 'never' served a sentence (19%). Six in ten, who had served '6-10 sentences' (64%) or 'over 10 sentences' (62%) had been under the influence of drugs at the time of their offence compared with a fifth (20%) of those who had 'never' served a sentence.

Overall drug treatment

One fifth of those who had 'never' served a sentence in prison (20%) were assessed for drug use on their admission to prison compared to over two thirds (69%) of those who have served 'over ten times'. Four times as many prisoners who had served 'over 10 sentences' (48%) had received help/treatment for their drug problem during a prison sentence, compared to those who had 'never' served a sentence (12%).

Overall alcohol use

Just under half of those who had served 'over 10 sentences' (45%) were drunk at the time of their offence, compared to 29% of those who had 'never' served a sentence. Twice as many of those in prison who served 'over 10 times' revealed that alcohol had affected their relationships with their family compared to the 'never' served a sentence before group (40% & 21% respectively)

AUDIT

Three quarters of prisoners drink alcohol, with a fifth doing so four or more times a week (18%). On a typical day when they are drinking, nearly a third of prisoners said that they would drink 10 or more drinks (31%). Almost a quarter of prisoners said that they have six or more drinks on one occasion weekly (22%), with a further 19% saying they would do this daily or almost daily.

Two thirds of those who said they had 'never' been in prison (66%) said that no one has been injured as a result of their drinking compared to only 38% of those serving 'over 10 sentences'. Similarly, three quarters (77%) of those who had 'never' been in prison before said 'no' when asked if a friend or relative or a doctor/health worker had been concerned about their drinking and suggested they cut down compared to 54% of those serving 'over 10 sentences'.

Overall Smoking

The more times an offender appears in custody, the more likely he or she is to smoke: 52% of the 'never' in custody group, 68% of the '1-5 times' group, 83% of the '6-10 times' group and 87% of the 'over 10 times' group were smokers. Although more than half of all smokers (53%) did express the desire to stop only one third would like to see smoke free prison introduced.

In Care

Of those prisoners who had been in prison 'over 10 times', half (49%) said that they were in care as a child compared to one in ten (12%) of those who had 'never' been in prison, one quarter (27%) of those in prison '1-5 times', and four in ten (38%) of those who have been in prison '6-10 times'. A similar pattern can be seen for those in care at the age of 16.

Mental Health and Well Being

When looking at mental health by the number of times respondents have been in prison, it can be see that generally the more times a respondent has served a sentence the less likely they are to respond positively when asked questions regarding their mental health and well-being.

Violence

Around a quarter of those in prison 'over 10 times' said that they were involved in (29%) or convicted (26%) of violence towards their spouse or partner compared to those who had 'never' been in prison before (20% and 14% respectively).

Over a third of those in prison 'over 10 times' (38%) said they were a victim of violence from their spouse or partner compared to a quarter (26%) of those who had 'never' been in prison before. Those in prison 'over 10 times' (51%) were much more likely than those who had 'never' been in prison (30%) to say that as a child they witnessed violence between their parents/carer.

Knife Crime

Looking at knife crime by the number of times a prisoner has been on a sentence, the data show that the more times a respondent has been in prison, the more likely it is that they would have been involved in knife crime. Over two thirds (69%) of those who had been in prison 'over 10 times' said that they have carried a knife compared to a fifth (20%) of those who have 'never' previously been in prison.

Six in ten (62%) of those serving 'over 10 sentences' said that they have previously used a knife to injure someone compared to 13% of those who had 'never' served a sentence. Similarly, almost two thirds (64%) of those serving 'over 10 sentences' said that they have been a victim of knife crime, with a fifth (21%) of those who had 'never' served a sentence before stating this.

Male offenders' drug use

Of the 'never' been in prison group, only six percent had used drugs in prison in the last month compared to half (49%) of the 'over 10 sentences' group. Just under half (47%) of the 'over 10 times' group were being prescribed methadone compared to 4% of the 'never' group. One third of those who had served 'over 10 times' (33%) reported using New Psychoactive substances prior to coming into prison compared to one in ten (11%) of those who had 'never' served a custodial sentence. Half of the 'over 10 times' group (49%) reported using New Psychoactive Substance during their time in prison compared to a minority 6% of those who had 'never' served a sentence before.

Male drug use at time of offence

Over half of male offenders who had served 'over 10 sentences' (56%) reported that their drug taking was a problem for them on the outside, compared to one fifth (18%) of those who had 'never' served a sentence.

Six in ten male offenders who served a sentence 'over 10 times' (62%) had been under the influence of drugs at the time of their offence compared to two in ten who had 'never' served a sentence (18%).

A third of those with 'over 10 sentences' had committed their offence to get money for drugs (35%), compared to only six per cent of those who had 'never' served a sentence.

Male offenders' drug treatment

Seven in ten male offenders who served 'over 10 sentences' reported that if they were offered help for their drug problem outside prison (70%) and in prison (68%) that they would take it, compared with a fifth of those who had 'never' served a sentence (17% and 18% respectively).

Half of those who had been in prison 'over 10 times' (49%) were worried that drug taking would be a problem for them on release into the community compared to five percent of the 'never' been in prison group. Almost half of those in the 'over 10 times' group had been given the chance to receive treatment for drug use during their sentence (46%) and had received help/treatment during their sentence (48%) compared to the 'never' group (16% and 11% respectively).

Male offenders' alcohol use

Four in ten male offenders reported being drunk at the time of their offence (39%), of these half had served a sentence '6 to 10 times' (51%), four in ten '1 to 5 times' (43%) and 'over ten times' (44%) and over a quarter had 'never' (29%) served a sentence in prison.

Over three times as many men in the 'over 10 times' group (30%) had experienced difficulties in holding down a job, compared to 8% in the 'never' group.

Twice as many male offenders in the 'over 10 times' group (39%) conceded that drinking had affected their relationship with their family compared to those who had 'never' served a prison sentence before (20%).

Just over a quarter of male offenders in the 'over 10 times group' (26%) were worried that alcohol will be a problem for them upon their release compared to seven percent of those in the 'never' group.

Male offenders Smoking

The more times a male offender appears in custody, the more likely he is to smoke: 52% of the 'never' group, 67% of the '1-5 times 'group, 82% of the '6-10 times' group and 87% of the 'over 10 times' group were smokers. However, over half of male smokers (53%) did express the desire to stop.

Half of prisoners in each group said they would use the prison stop smoking service. Three quarters in each group stated that they would use e-cigs if they were available in prison. A significantly higher percentage of many male offenders in the 'never' group (41%) would like to see smoke-free prisons compared with those in the 'over 10 times' group (24%).

Women in custody drug use at time of offence

Twice as many women who had served 'over 10 sentences' (68%) reported that their drug taking was a problem for them on the outside compared to those who had 'never' served a sentence (33%). Three quarters of women who served a sentence '1-5 times' (75%) or '6-10 times' (75%) had been under the influence of drugs at the time of their offence compared to a third (34%) of those who had 'never' served a sentence.

Women in custody drug treatment

Three quarters of women who served 'over 10 sentences' (77%) reported that if they were offered help for their drug problem in prison they would take it compared with one third of those who had 'never' served a sentence (34%). Twice as many of those who had been in prison 'over 10 times' (40%) were worried that drug taking would be a problem for them on release into the community compared the 'never' (21%) been in prison group.

Half of those women who have served a prison sentence 'over 10 times' (53%) were assessed for drug use upon their admission to prison compared to one third of those who had 'never' served a custodial sentence group (32%).

Women in custody alcohol use

Just over half of women in custody (52%) who had served a sentence 'over 10 times'

reported being drunk at the time of their offence, compared to one third (31%) of those who had 'never' been in prison before. Between a third and a half of the women conceded that drinking had affected their relationship with their family, suggesting an entrenched problem with alcohol in the community setting.

Half of those who had served a sentence 'over 10 times' (50%) were worried that alcohol would be a problem for them upon their release, compared to 15% of those who had 'never served a sentence.

Women in custody Smoking

The more times a women appears in custody, the more likely she is to smoke: 53% of the 'never' group, 90% of the '1-5 times 'group, 87% of the '6-10 times' group and 91% of the 'over 10 times' group were smokers. However, almost half of these women (48%) did express the desire to stop smoking.

Half of women in each group said they would use the prison stop smoking service. Three quarters in each group stated that they would use e-cigs if they were available in prison. A significantly higher percentage of many women in the 'never' group (47%) would like to see smoke-free prisons compared with those in the 'over 10 times' group (19%).

Introduction

This Bulletin, which deals specifically with the custodial history of prisoners held by the Scottish Prison Service, is one of a number of thematic commentaries presenting the key findings from the 2017 Prisoner Survey.

The Survey, which is undertaken in each of the 15 Scottish prisons, involves all Scottish prisoners.¹ Of the 93% of males and six per cent of females in custody, 80% were convicted and 20% were untried. One third of those in custody were aged between 30 and 39 years, a quarter (23%) were age 21 to 29 years and one fifth (20%) were 40 to 49 years of age. A minority 7% were aged between 16 and 20 years and the remaining 20% of the prisoners reporting in the survey were 50 years of age and over.

Content and coverage

The Survey is conducted every two years and focuses upon the core elements of prison life: living conditions, family contact, healthcare, relationships and atmosphere. It also seeks views on such issues as perceived safety, bullying, drug use, military service mental health and in care as a child. As it is completed in a relatively short timeslot it purposely avoids detailed questions on complex issues.

The Survey is distributed to all prisoners and all establishments within Scotland, so in that regard, the exercise is a census. The 2017 questionnaire was translated into three key foreign languages and interpreters were also provided as necessary on fieldwork day.

¹ The 2017 Survey fieldwork covered the period May to July 2017. Establishments were given the option either to distribute the questionnaires or have the research team do so. Prior to these visits, posters were displayed in prominent areas in the prison informing prisoners and staff of the Survey and the day it would take place in their establishment. The evening prior to the Survey, each prisoner was given a leaflet informing them of the Survey and its aims. On the day of the Survey, prisoners were issued with a survey form by a member of the Survey Team or prison staff. After being given the chance to complete the questionnaire in the privacy of their cell, the completed forms (sealed in an envelope) were personally collected by a member of the Survey Team or prison staff. This methodology helps ensure that when handing out the forms each prisoner is given a brief explanation of why the Survey is taking place and has an opportunity to ask questions.

Custodial history

Prison History

One fifth (20%) of prisoners said that they were on remand at the time of completing the 2017 prisoner survey; 80% had been sentenced.

Respondents' remand and custodial history is outlined in Table 1. This shows that prisoners were more likely to report being on remand between '1 and 5 times' (43%). Over a quarter of prisoners said that they had 'never' previously been on remand (29%). Sixteen percent of those reporting had been on remand 'over 10 times' and one tenth between '6 and 10 times' (11%).

One third of those reporting had 'never' previously served a prison sentence (35%), while four in ten had served between '1 and 5 sentences' (39%), 11% between '6 and 10 sentences', and 15% had served 'over 10 sentences'.

Sentence length

Table 2 below shows the sentence length of those prisoners reporting in the survey. One third are serving a sentence of over 1 year up to 4 years (35%), followed by a quarter serving over 4 years up to 10 years (23%), and one fifth serving over 3 months and up to 12 months (20%). A minority (5%) are serving over 10 years, and one in ten respondents are serving a Life/WLT sentence (11%).

Two fifths of prisoners said that they had previously served a sentence in the community (41%). Just over a quarter said that they have received a custodial sentence as a result of breaching a community sentence (27%).

Overall drug use

Table 3 shows a considerable difference between those prisoners who had 'never' served a custodial sentence before and those who had served 'over 10 times' in relation to illegal drug use in prison (14% & 77% respectively) and illegal drug use in the last month (6% & 50% respectively).

Just under half (48%) of the 'over 10 times' group were being prescribed methadone compared to six percent of the 'never' group.

Overall drug use at time of offence

Over half of prisoners who reported that their drug taking was a problem for them on the outside had been in prison on a sentence '6-10 times' (57%) or 'over 10 times' (57%), compared with a fifth who had 'never' served a sentence (19%). Six in ten, who had served '6-10 sentences' (64%) or 'over 10 sentences' (62%) had been under the influence of drugs at the time of their offence compared with a fifth (20%) of those who had 'never' served a sentence.

One third of those who served 'over 10 sentences' had committed their offence to get money for drugs (35%), compared with seven percent of prisoners who had 'never' served a sentence. Half of those who had served 'over 10 sentences' (50%) reported receiving treatment for their drug use before imprisonment compared with one in ten (8%) of those who had 'never' served a prison sentence. Table 4 highlights the increasing drug use amongst those prisoners who have served more sentences.

Overall drug treatment

Over two thirds of those prisoners who served 'over 10 sentences' reported that if they were offered help for their drug taking in prison/outside prison that they would take it (70% and 69% respectively) compared with a fifth (18% and 20% respectively) of those who had 'never' served a sentence.

One fifth of those who had 'never' served a sentence in prison (20%) were assessed for drug use on their admission to prison compared to over two thirds (69%) of those who have served 'over ten times'.

Four times as many prisoners who had served 'over 10 sentences' (48%) had received help/treatment for their drug problem during a prison sentence, compared to those who had 'never' served a sentence (12%).

Almost half of the 'over 10 times' group (48%) were worried that drug taking would be a problem on release, compared to seven per cent of the 'never' been in prison group (Table 5).

Overall alcohol use

Just under half of those who had served 'over 10 sentences' (45%) were drunk at the time of their offence, compared to 29% of those who had 'never' served a sentence. Over three times as many prisoners who had served 'over 10 sentences' said that they were worried that alcohol would be a problem for them when they got out (28%) compared to those who had not served a sentence before (8%). A similar percentage of the 'over 10 times' group (31%) admitted that drinking had affected their ability to hold down a job, compared to 9% of the 'never' in prison group.

Twice as many of those in prison who served 'over 10 times' revealed that alcohol had affected their relationships with their family compared to the 'never' served a sentence before group (40% & 21% respectively - see Table 6).

AUDIT

As part of the 2017 survey, the Alcohol Use Disorders Identification Test (AUDIT) was incorporated into the section asking prisoners about their alcohol use prior to going to prison. Table 7 shows the responses to each of the 10 AUDIT questions for the overall prisoner survey sample.

Three quarters of prisoners drink alcohol, with a fifth doing so four or more times a week (18%). On a typical day when they are drinking, nearly a third of prisoners said that they would drink 10 or more drinks (31%). Almost a quarter of prisoners said that they have six or more drinks on one occasion weekly (22%), with a further 19% saying they would do this daily or almost daily.

Around one fifth of prisoners said that weekly or daily/almost daily that they: found they were not able to stop drinking once they had started (23%); failed to do what was normally expected of them because of their drinking (19%); needed a first drink in the morning to get themselves going after a heavy drinking session (17%); had a feeling of guilt or remorse after drinking (20%); or had been unable to remember what happened the night before because they had been drinking (20%).

A full breakdown by the number of times a prisoner has been in custody can be found in the Annex. When looking at the AUDIT questionnaire in relation to sentence frequency, generally, the more sentences a prisoner has served, the more likely they are to engage in harmful drinking.

Over a quarter of offenders who had been in prison 'over 10 times' (27%) said they drank a drink containing alcohol 4 or more times a week compared to one in ten who had 'never' been in prison (11%). Twice as many of those who had been in prison 'over 10 times' (41%) said that they had 10 or more drinks containing alcohol on a typical day when they are drinking compared to those who had 'never' been in prison before (21%).

A third of offenders serving 'over 10 times' said that daily or almost daily they would have six or more drinks on one occasion (33%) compared to only ten per cent of those who had 'never' served a sentence. A quarter of those serving 'over 10 sentences' (23%) said that daily or almost daily they found that they were not able to stop drinking once they had started compared to six percent of those who had 'never' served a sentence.

Two thirds of those who said they had 'never' been in prison (66%) said that no one has been injured as a result of their drinking compared to only 38% of those serving 'over 10 sentences'. Similarly, three quarters (77%) of those who had 'never' been in prison before said 'no' when asked if a friend or relative or a doctor/health worker had been concerned about their drinking and suggested they cut down compared to 54% of those serving 'over 10 sentences'.

One fifth of prisoners who had served 'over 10 sentences' (20%) compared to only three per cent who had 'never' been in prison before said that daily or almost daily they had failed to do what was normally expected from them because of their drinking.

One quarter (23%) of those serving 'over 10 sentences' said that they daily or almost daily in the last year have needed a first drink in the morning to get themselves going after a heavy drinking session compared to five per cent who had 'never' been in prison.

Again, one fifth (20%) of those serving 'over 10 sentences' said that they daily or almost daily had a feeling of guilt or remorse after drinking compared to seven per cent of those who had 'never' served a sentence.

Lastly, 18% of those who have been in prison 'over 10 times' compared to six per cent of those who had 'never' been in prison said that daily or almost daily in the last year they have been unable to remember what happened the night before because they had been drinking (See Annex).

Overall Smoking

The more times an offender appears in custody, the more likely he or she is to smoke: 52% of the 'never' in custody group, 68% of the '1-5 times' group, 83% of the '6-10 times' group and 87% of the 'over 10 times' group were smokers. Although more than half of all smokers (53%) did express the desire to stop only one third would like to see smoke free prison introduced (see Annex).

In Care

There is a strong correlation between the number of times a prisoner has been in prison and whether they were previously in care. Of those prisoners who had been in prison 'over 10 times', half (49%) said that they were in care as a child compared to one in ten (12%) of those who had 'never' been in prison, one quarter (27%) of those in prison '1-5 times', and four in ten (38%) of those who have been in prison '6-10 times'. A similar pattern can be seen for those in care at the age of 16 (see Annex).

Mental Health and Well Being

Prisoners were asked questions on mental health by way of an instrument known as the Warwick-Edinburgh Mental Well-being Scale (WEMWBS) (See Table 8). When looking at mental health by the number of times respondents have been in prison, it can be see that generally the more times a respondent has served a sentence the less likely they are to respond positively when asked questions regarding their mental health and well-being (see Table 8).

Violence

Around a quarter of those in prison 'over 10 times' said that they were involved in (29%) or convicted (26%) of violence towards their spouse or partner compared to those who had 'never' been in prison before (20% and 14% respectively).

Over a third of those in prison 'over 10 times' (38%) said they were a victim of violence from their spouse or partner compared to a quarter (26%) of those who had 'never' been in prison before. Those in prison 'over 10 times' (51%) were much more likely than those who had 'never' been in prison (30%) to say that as a child they witnessed violence between their parents/carer.

Knife Crime

Looking at knife crime by the number of times a prisoner has been on a sentence, the data show that the more times a respondent has been in prison, the more likely it is that they would have been involved in knife crime. Over two thirds (69%) of those who had been in prison 'over 10 times' said that they have carried a knife compared to a fifth (20%) of those who have 'never' previously been in prison.

Six in ten (62%) of those serving 'over 10 sentences' said that they have previously used a knife to injure someone compared to 13% of those who had 'never' served a sentence. Similarly, almost two thirds (64%) of those serving 'over 10 sentences' said that they have been a victim of knife crime, with a fifth (21%) of those who had 'never' served a sentence before stating this. Bullying and Safety

Roughly similar numbers of those who had 'never' been in prison before (17%) and those who had been in prison 'over 10 times' (18%) reported that they have been bullied in the last month in prison. Again, similar numbers of those who had 'never' been in prison before (15%) and those who had been in prison 'over 10 times' (19%) reported that they feared for their safety in the last month (See Annex).

Custodial history of male offenders

Male offenders' drug use

Table 10 shows a considerable difference between those male prisoners who had 'never' served a custodial sentence before and those who had served 'over 10 times' in relation to and illegal drug use in prison (13% & 76% respectively). Of the 'never' been in prison group, only six percent had used drugs in prison in the last month compared to half (49%) of the 'over 10 sentences' group. Just under half (47%) of the 'over 10 times' group were being prescribed methadone compared to 4% of the 'never' group.

One third of those who had served 'over 10 times' (33%) reported using New Psychoactive substances prior to coming into prison compared to one in ten (11%) of those who had 'never' served a custodial sentence. Four in ten of the 'never' group (49%) reported using New Psychoactive Substance during their time in prison compared to a minority 6% of those who had 'never' served a sentence before.

Male drug use at time of offence

Over half of male offenders who had served 'over 10 sentences' (56%) reported that their drug taking was a problem for them on the outside, compared to one fifth (18%) of those who had 'never' served a sentence.

Six in ten male offenders who served a sentence 'over 10 times' (62%) had been under the influence of drugs at the time of their offence compared to two in ten who had 'never' served a sentence (18%). A third of those with 'over 10 sentences' had committed their offence to get money for drugs (35%), compared to only six per cent of those who had 'never' served a sentence. This can be seen in Table 11.

Male offenders' drug treatment

Table 12 shows that seven in ten male offenders who served 'over 10 sentences' reported that if they were offered help for their drug problem outside prison (70%) and in prison (68%) that they would take it compared with a fifth of those who had 'never' served a sentence (17% and 18% respectively).

Half of those who had been in prison 'over 10 times' (49%) were worried that drug taking would be a problem for them on release into the community compared to five percent of the 'never' been in prison group.

Two thirds of male offenders in the 'over 10 times group' were assessed for drug use upon their admission to prison compared to one fifth of those who had 'never' served a prison sentence (18%).

Almost half of those in the 'over 10 times' group had been given the chance to receive treatment for drug use during their sentence (46%) and had received help/treatment during their sentence (48%) compared to the 'never' group (16% and 11% respectively).

Male offenders' alcohol use

Four in ten male offenders reported being drunk at the time of their offence (39%), of these half had served a sentence '6 to 10 times' (51%), four in ten '1 to 5 times' (43%) and 'over ten times' (44%) and over a quarter had 'never' (29%) served a sentence in prison.

Over three times as many men in the 'over 10 times' group (30%) had experienced difficulties in holding down a job, compared to 8% in the 'never' group.

Twice as many male offenders in the 'over 10 times' group (39%) conceded that drinking had affected their relationship with their family compared to those who had 'never' served a prison sentence before (20%).

Just over a quarter of male offenders in the 'over 10 times group' (26%) were worried that alcohol will be a problem for them upon their release compared to seven percent of those in the 'never' group (see Table 13).

Male offenders Smoking

The more times a male offender appears in custody, the more likely he is to smoke: 52% of the 'never' group, 67% of the '1-5 times 'group, 82% of the '6-10 times' group and 87% of the 'over 10 times' group were smokers. However, over half of male smokers (53%) did express the desire to stop.

Half of prisoners in each group said they would use the prison stop smoking service. Three quarters in each group stated that they would use e-cigs if they were available in prison. A significantly higher percentage of male offenders in the 'never' group (41%) would like to see smoke-free prisons compared with those in the 'over 10 times' group (24%) (See Annex).

Custodial history of women in custody

Table 14 shows the differences between those women who have 'never' served a custodial sentence before and those who had served 'over 10 times' in relation to drug use in prison (20% & 90% respectively) and illegal drug use in prison in the last month (11% & 67% respectively).

Women in custody drug use at time of offence

Table 15 highlights the increasing drug use amongst those prisoners who have served more sentences, although it should be noted that the 'baseline' figures for the 'never' in prison group are considerable higher than male counterparts, again confirming the proportionally greater problematic drug use in the community of those women who end up in custody.

Twice as many women who had served 'over 10 sentences' (68%) reported that their drug taking was a problem for them on the outside compared to those who had 'never' served a sentence (33%). Three quarters of women who served a sentence '1-5 times' (75%) or '6-10 times' (75%) had been under the influence of drugs at the time of their offence compared to a third (34%) of those who had 'never' served a sentence.

Women in custody drug treatment

Three quarters of women who served 'over 10 sentences' (77%) reported that if they were offered help for their drug problem in prison they would take it compared with one third of those who had 'never' served a sentence (34%). Twice as many of those who had been in prison 'over 10 times' (40%) were worried that drug taking would be a problem for them on release into the community compared the 'never' (21%) been in prison group.

Half of those women who have served a prison sentence 'over 10 times' (53%) were assessed for drug use upon their admission to prison compared to one third of those who had 'never' served a custodial sentence group (32%). (See Table 16).

Women in custody alcohol use

Just over half of women in custody (52%) who had served a sentence 'over 10 times' reported being drunk at the time of their offence, compared to one third (31%) of those who had 'never' been in prison before. Between a third and a half of the women conceded that drinking had affected their relationship with their family, suggesting an entrenched problem with alcohol in the community setting. This can be seen in Table 17.

Half of those who had served a sentence 'over 10 times' (50%) were worried that alcohol would be a problem for them upon their release, compared to 15% of those who had 'never served a sentence.

Women in custody Smoking

The more times a women appears in custody, the more likely she is to smoke: 53% of the 'never' group, 90% of the '1-5 times 'group, 87% of the '6-10 times' group and 91% of the 'over 10 times' group were smokers. However, almost half of these women (48%) did express the desire to stop smoking.

Half of women in each group said they would use the prison stop smoking service. Three quarters in each group stated that they would use e-cigs if they were available in prison. A significantly higher percentage of many women in the 'never' group (47%) would like to see smoke-free prisons compared with those in the 'over 10 times' group (19%) (See Annex).

Conclusion

Successive Prisoner Surveys have been able to report a decline in self-reported drug use since the early 2000s. The number of prisoners reporting they have 'ever used illegal drugs in prison' decreased from 58% in 2001 to 39% in 2017.

However, this thematic Bulletin has examined custodial history and substance misuse and has found, not unexpectedly, that the greater the number of times an offender has been incarcerated, the greater the association with problematic drug and alcohol use. It is not entirely clear though, whether it is increasingly problematic substance misuse which leads to repeat offending and successive jail sentences or whether successive jail sentences prompt and promote hazardous substance misuse in the community and in prison as a mechanism for coping with life's adversities. Common sense would suggest that both of these propositions have explanatory power and in reality, probably act in consort to reinforce chaotic lifestyles, substance misuse, addiction and offending behaviour.
