## Dear

Thank you for your request dated 4 July 2024 under the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

For reference, you requested:

**RFI 1:** "For each prison in Scotland, how many prisoners are currently held in them, and how many are they meant to hold? This data should be provided for the last five years, to the date of your reply."

**RFI 2:** "For each prison in Scotland, how many staff are there (not administrative etc, only prison staff directly), and how many vacancies are there? This should also be provided for the last five years, to the date of your reply."

**RFI 3:** "The number of people who are currently serving an Indeterminate Sentence for Public Protection (IPP) in each prison in Scotland. This should include:

- which crimes they are serving an IPP for (in detail)
- how long they have been serving an IPP for
- How many people serving an IPP have been recalled to prison after they committed an offence."

We have now completed our search for the information you requested which has been provided.

**RFI 1 Response:** Please find in the table below, the breakdown of prisoners currently held within all prisons in Scotland on 1 August 2024 and their design capacity.

The table above captures the substantive vacancies that fall within the scope of your request. To clarify, within the operational roles that the request relates to, SPS has an agreed number of posts which may be filled on a part-time or full-time basis. One full-time equivalent (FTE) vacancy would equate to 1.0 so any reported number below 1.0 means there is part of a full-time equivalent post which is vacant. For example, a vacancy position of 1.5 means there is a full-time vacancy (the 1.0), plus one half of a full-time vacancy (the 0.5), which could be filled on a part-time basis.

**RFI 3 Response:** There are less than five prisoners in SPS custody serving an Indeterminate Sentence for Public Protection.

We do endeavour to provide information whenever possible. However, in this instance an exemption under section 38(1)(b) (personal information) of FOISA applies to the information requested. Personal data is exempt from disclosure if disclosure would contravene any of the data protection principles in Article 5(1) of the UK GDPR and in section 34(1) of the DPA 2018. The Scottish Prison Service seeks to be as open and transparent as possible, while also upholding our statutory obligation to protect the personal information of those in our care. The information you have requested relates to a small group of individuals and providing the information requested could, together with other available information lead to their inadvertent identification.

This concludes our response to your request.

If you are unhappy with this response to your request, you may ask us to conduct an internal review, by writing to The Chief Executive, One Lochside, 1 Lochside Avenue, Edinburgh, EH12 9DJ. Your request should explain why you wish a review to be conducted and should be made within forty working days of receipt of this letter, and we will reply within twenty working days of receipt. If you are not satisfied with the result of the review, you then have the right to make a formal complaint to the Scottish Information Commissioner.
