## Dear

Thank you for your request dated 26 September 2024 under the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

For reference, you requested:

**RFI 1:** "The total number of data protection breaches that have occurred during each year since 2018? For each breach reported, please provide (a) the year of the breach, (b) the department involved and (c) the number of individuals affected?"

**RFI 2:** "Please provide information on whether any serious data breaches (as defined under GDPR) have failed to be reported to the Information Commissioner's Office (ICO) within the legally required 72-hour period and the year of the breach?"

If possible, I would appreciate it if you could display the information in a table or on Excel.

We have now completed our search for the information you requested.

**RFI 1 Response:** Under section 17 of FOI(S)A I can advise that the SPS does not hold the information you have requested in relation to the number of data protection breaches or individuals affected as this did not form part of the SPS corporate reporting on information incidents for previous financial years.

SPS has a system in place to record all information security incidents reported by staff. In order to help and assist your request we have provided a table below showing the number of information security incidents recorded for each financial year but please note an information security incident does not necessarily constitute a data protection breach.
