RFI 3 Response: The Scottish Prison Service (SPS) records all deaths in custody in calendar years and publishes this information on SPS' external website. This information is available for the previous ten years and is updated on a quarterly basis by SPS. Please find enclosed (HQ24245 Annex A) published information on deaths in custody.

We do not collate Hall information following a death in custody. We do endeavour to provide information whenever possible. However, in this instance the costs of locating, retrieving, and providing the information requested would exceed the upper cost limit of £600. This is because the information is not held in a readily available format. Under section 12 of FOISA public authorities are not required to comply with a request for information if the authority estimates that the cost of complying would exceed the upper cost limit, which is currently set at £600 by Regulations made under section 12.

RFI 4 Response: For the purposes of this request, we have interpreted the term 'officers' to relate to Operational Officers at Pay Band C, Residential Officers at Pay Band D and First Line Managers at Pay Band E i.e. those staff undertaking uniformed, prisoner officer duties.

41 prison officers have deceased since 1 January 2014. To clarify, this figure does not reflect the number of prison officer who have died whilst on duty, but rather whilst in service/employed by our organisation.

This concludes our response to your request.

If you are unhappy with this response to your request, you may ask us to conduct an internal review, by writing to The Chief Executive, One Lochside, 1 Lochside Avenue, Edinburgh,

Your request should explain why you wish a review to be conducted and should be made within forty working days of receipt of this letter, and we will reply within twenty working days of receipt.
