## Dear

Thank you for your request dated 26 May 2025 under the Freedom of Information (Scotland) Act 2002 (FOI(S)A).

For reference, you requested:

**RFI 1:** "As of 26 May 2025, how many assaults on Scottish Prison staff by inmates have been recorded in the last calendar year? How many were recorded in 2024, 2023, 2022 and 2021? Please break this down by individual prison."

**RFI 2:** "As of 26 May 2025, how many assaults by inmates on fellow inmates have been recorded in the last calendar year? How many were recorded in 2024, 2023, 2022 and 2021? Please break this down by individual prison."

**RFI 3:** "As of 26 May 2025, how many people are employed by the Scottish Prison Service? Please break this down by staff role (ie: 1000 operational officers, 1500 residential officers). How many were employed in 2024, 2023, 2022, and 2021?"

**RFI 4:** "As of 26 May 2025, how many Scottish Prison staff members have left their jobs due to mental ill health in the last calendar year? How many left their jobs in 2024, 2023, 2022, and 2021?"

**RFI 4 Response:** The way the Scottish Prison Service records the details of those staff members leaving our employment does not allow us to respond to your query in full.

To clarify, we do not hold information on those staff who have left our employment due to their mental ill health or employees who may have resigned citing their mental ill health as the reason. We can, however, identify employees who have left the service via capability dismissal whose reason for absence falls within the "mental ill health" category.
