Thank you for your request dated 07 September 2026 under the Freedom of Information (Scotland) Act 2002 (FOISA).

For reference, you requested.

RFI 1: *“In what establishments within the Scottish Prison Service estate are the following programmes being facilitated: Moving Forward 2 Change, Self Change Programme (SCP) (Offence Protection).”*

RFI 2: *“How many groups of each programme, as above, are being facilitated within each participating establishment?”*

RFI 3: *“How many individuals are in the waiting list for each programme, as above, to join on a: Group basis, one-to-one basis.”*

RFI 4: *“How many individuals completed the self change programme (offence protection) in the years: 2024-2025, 2025-2026, 2026-to date.”*

RFI 5: *“How many individuals completed the Moving Forward to Change (MF2C) programme in the years 2024-2025, 2025-2026, 2026-to date.”*

We have now completed our search for the information you requested.

RFI 1 Response: Please see below as at 08 September 2026.

- Moving Forward 2 Change (MF2C) – HMP Barlinnie, HMP Edinburgh and HMP Glenochil
- Self-Change Programme (SCP) – HMP Edinburgh (Offence Protection), HMP Glenochil (Offence Protection) and HMP Grampian ((1:1) or (2:1) for any category of prisoner who require individual rather than groupwork),

RFI 2 Response: All establishments noted in RFI 1 above are currently running one group of each of the programmes listed.

RFI 3 Response: Waiting lists are dynamic but as of 08 September 2026, there are 162 individuals waiting to access the MF2C programme on a group basis and 7 waiting to access MF2C on an individual basis.

As of 08 September 2026, there are 100 individuals from the offence protection population waiting to access the Self Change Programme on a group basis and 14 individuals from the offence protection population waiting to access the Self Change Programme on an individual basis.

RFI 4 Response: The programme completion figures for the Self Change Programme (Offence Protection) are listed below. Please note that the information is recorded by financial year i.e. 01 April – 31 March.
